ThoughtFarmer is partnered with AWS for cloud hosting with data centers in the US, Canada, and Ireland. ThoughtFarmer Cloud is monitored and optimized for fast speeds and high concurrency and ensures customers get up and running quickly. We also take care of upgrades, during a scheduled time that works for your organization.

Cloud security

ThoughtFarmer Cloud is SOC 2 Type II compliant and subject to rigorous third-party network vulnerability scans, intrusion detection monitoring, and penetration tests. All customer data is backed up regularly.

ThoughtFarmer also replicates to a secondary availability zone for disaster recovery to ensure continuity and redundancy. Security is baked into the development process from the start by using a secure software development lifecycle.

- Providing data privacy and compliance training for employees.

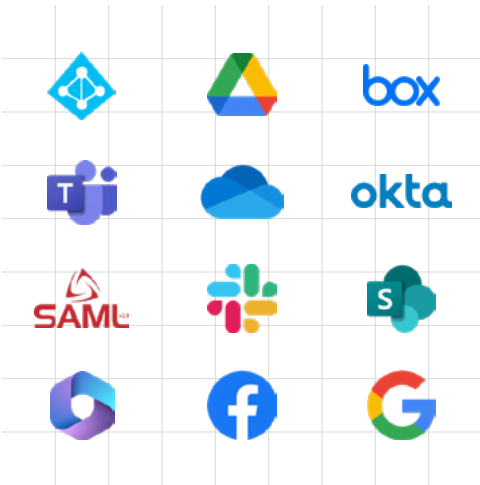
Identity management and authentication

- We integrate with every major SAML provider, including Azure AD, G Suite, OneLogin, OKTA and Ping Identity. We support native multi-factor authentication and third party providers, and ThoughtFarmer can be configured to use more than one provider for complex deployments.
- We offer automatic user synchronization for Active Directory, Azure AD, G Suite, and OKTA. ThoughtFarmer's bi-directional directory synchronization keeps groups, profile pictures, security profiles, and employee contact information up to date across systems.
